WRITTEN UNDERTAKING ON NON-FRATERNITY INVOLVEMENT

after having been duly sworn in accordance with law, depose and state that:

1. I voluntarily choose Mountain View College (hereinafter called the college) as school and I understand that it is a school whose philosophy, mission, practices and core values are distinctively Adventist since it is owned by the Seventh-day Adventist.
2. I understand that the College does not authorize, allow, and/or recognize fraternities, sororities, and other organizations of similar nature and characteristics as such organizations have practices that contradict the practices and core values of the College;
3. I voluntarily declare that I am a member of _____ fraternity, sorority, or organization which the College does not recognize, but I hereinafter promise, commit and pledge that I shall be inactive in my membership from the said Fraternity/ Sorority while enrolled at Mountain View College, and when and if my academic credentials are still with the college, and I am voluntarily submitting to the College rules, regulations and the Student Behavior Code related to the said organizations.
4. I do not intend to conduct activities related to any fraternity, sorority or group of similar nature during my entire stay in this College;
5. I fully acknowledge and understand that my admission to the College is a privilege, and not a right, and that the College has the right and authority to choose the person or individuals that may be admitted as students of the college;
6. I acknowledge and understand that the College has likewise the authority to prescribe rules and regulations governing non-membership of students in any fraternity, sorority, or organization in the College and that the school could validly institute this rule because they are based on the constitutional right of schools of higher learning to prescribe the conditions they may require of any persons or individuals aspiring to become their student. I am therefore conforming to the following rationale of the College in this regard:
 - a. It is the right of schools of higher education to withhold recognition to fraternities, sororities or organizations considered inimical to peace and order in school campus;
 - b. The formation of exclusive organizations or groups in the College is disruptive of the unity and peace the College wished to foster among members of the academic community;
 - c. The presence of fraternities or sororities has in the past contributed to campus violence;
 - d. The membership in fraternities or sororities has a tendency to develop an attitude of exclusivity and sometimes hardened character in students which is contrary to the College's mission, beliefs, and values;
 - e. and the absence of fraternities or sororities helps in the broadening of friendship among MVC students and eliminates the divisive effects of exclusivity.

7. I recognize and accept that my continued stay in the College is subject to my compliance with prescribed discipline policies, rules and regulations especially with my non-membership in fraternities or sororities; and

8. I understand and accept that the College can impose sanctions or measures, dismiss or expel me if I would be found having violated the condition to this written undertaking as well as having falsely certified any information stated herein.

I am executing and submitting this undertaking as a prerequisite of my admission and continued privilege as a student of the Mountain View College.
